Subject: Choreography, music, sets, costume, lighting design and staging of **GNAWA**

The two parties made following amendment to the above-mentioned contract:

I.

For compelling technical reasons the Company accepts the payment of 2 (two) air tickets for Nicolas Fischtel, light designer and accommodation in Brno during his two stays in Brno, ie 7 flights in total for the participants on this project as agreed in the contract.

II.

Referring to the provisions of Article 4. Items 4.1-4.3 the amount of 48.500,- Euro gross, agreed in Art. 2, items 2.1 and 2.2 of the agreement 2018/03/09 – Gnawa, will be increased by 2.950,96 Euro gross covered the costs of the air tickets and accommodation in Brno specified in the Annex No 1 to this Ammendment No 1, which is the integral part of the above agreement.

The total amount of the Agreement after the above increase will be 51.450,96 Euro net.

The Company paid all the costs given in the Annex No 1 in the amount of 2.950,96 Euro in total.

The Organizer agrees with the deduction the above costs of the total amount of 51.450,96 Euro before payment the 2nd installment of the agreed sum.



5. The amendment No 1 enters into force and validity on the day of its signature by the Parties.


